

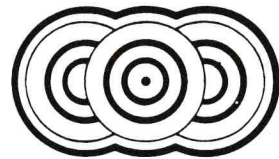

BUCKEYE OPEN A SUCCESS

C.O.D.'s \$5200 1st Annual Buckeye Open was a success almost any way you measure it. We had a good crowd (made up mostly of C.O.D. members and Cleveland, Cincinnati and Dayton darters here for the Challenge), the tournament ran smoothly, many compliments were received from out-of-towners on the tournament itself and the Quad-City Challenge, and best of all, C.O.D. had many players place in the top or near the top of their events.

The Friday night blind draw crowd knew a good bet when they heard one and voiced their most dramatic "ooo's" and "ah's" when the team of Jim Medley and Niles Overly was announced. They called it! Niles and Jim did go on to win the event over 75 other teams.

Another bright spot for C.O.D. was our own Men's All-Star Team Captain Mike Tackett making it to the finals of the 501 Open Singles (137 entries). Mike's Goosetown Astonishers' teammate, Dave Holmes, got himself to the semi-finals in that event, as did Nan Gehlhar in the Women's 501 Singles. We also had a team of semi-finalists (Dan Tedrick and Jack Clifford) in the Cricket Open Doubles.

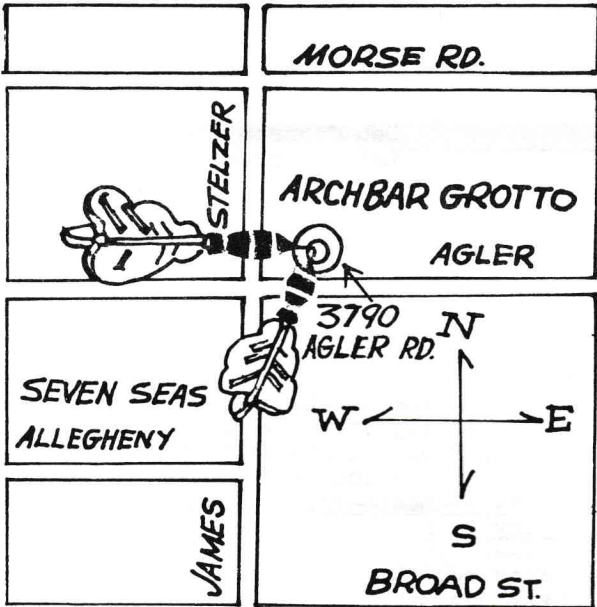

Executive Vice-President: Jay reported on the upcoming tournaments. Bill will see that these are printed in the standing sheet. Jay also mentioned that USA Holiday Travel has 30% off regular coach fare for ADO members attending dart tournaments.

Treasurer: Charlie passed out his report for the final fiscal year and the proposed budget for 1983-84. Bill made a motion to put the carry over into the building fund. Mark seconded and the motion passed. Bill made a motion to accept the proposed budget submitted by Charlie. Walter seconded and the motion passed. Bill made a motion to form a committee, which he will head, to discuss with Charlie the possibility of becoming a non-profit organization. Mike seconded and the motion passed.

Trophy Committee: Jay brought in the corrected trophies requested from last meeting.

Bar Relations: Tom reported some problems with Spankey's. The manager is willing to hire a bouncer if Tom will get him copies of the complaints.

Newsletter: The deadline has been extended to Tuesday, October 11th. Shirley brought up the advertising contract we are currently using. It reads that we will accept camera-ready

art for ads or we will make it camera ready. Bill made a motion that we amend our advertising contract stating that we will accept camera ready art only and that we will recommend an artist for those who do not submit camera ready art. Charlie seconded and the motion passed.

Beginner's League: Mike will start this league on Tuesday October 11th at the Hey Hey Lounge. The first night of play will begin on the following Tuesday. It will depend on how many players sign up as to how many weeks this will run.

Pittsburgh Tournament: Jay asked to rent easels for this tournament. Bill made a motion to rent 24 easels for \$200 for the weekend to Bull's Eye Marketing. Charlie seconded and the motion passed. Jay will be responsible for getting the easels to and from Pittsburgh.

Board Members: Bill recommended that board members who serve a full term be rebated their \$20 membership fee at the end of their term. This was tabled until the next meeting.

Buckeye Open: Bill made a motion to sponsor a 2nd Annual Buckeye Open for \$5,000 for December of 1984 at this time so we can take advantage of the free advertising in the ADO calendar. Mike seconded and the motion passed.

T-80 Club: Mark will be sending in the T80's for the COD members to the ADO.

Bar Relations: Bill read some bar complaints concerning light and bad boards.

Rebate Fund: Becky reported \$538.00 in the rebate fund. The fund will be used at the Buckeye Open tournament for the "buy one get one free." Scottie made a motion for COD to supplement the balance of anything over and above the amount of the rebate fund used at the Buckeye Open
